I also waive any right to inspect or approve any photo, video, or film taken of me while participating during the Program, including but not limited to, any program training, treatments, demonstrations, and related activities. I affirmatively release, hold harmless, and discharge Rhys Thomas Institute from responsibility for any depiction of any photos, video, audio recordings, or film taken of me while participating during the Program, including but not limited to, any program training, treatments, demonstrations, and related activities.

I agree that Rhys Thomas shall own all right, title, and interest in and to my name, voice, and likeness and the irrevocable copyright therein, throughout the world in perpetuity for any and all photographs, video, audio recordings, or film taken of me during the Program, including but not limited to, any program training, treatments, demonstrations, and related activities.
